ORDER

This permission is granted subject to the following terms and conditions:

1. The use of above mentioned vehicle shall be used for Election Work only.
2. The applicant should obey the order of Hon'ble Supreme Court of India.
3. The applicant should follow all the rules and regulations, Code of conduct and other directions given by the Election Commission of India & Chief Electoral Officer, DNH&DD.
4. The conditions prescribed in the Model Code of Conduct for the guidance of Political parties and Candidates should be adhered to strictly.
5. The Vehicle driver should keep copy of valid Driving License/R.C. Book/ PUC / insurance and produce the same as when demanded by Police Officer/ Special Magistrate or any other authorized officer.
6. No voters are allowed to be transported in the above mentioned vehicle.
7. The applicant shall ensure that no obstruction to the traffic or flow of traffic takes place on any road and should follow the traffic rules.
8. In case of any untoward incident the applicant will be solely responsible for the incident.
9. There should not be more persons than permitted sitting capacity in the vehicle (as mentioned in the RC book).
10. The applicant shall follow any other orders issued by the Administration and Police Department, DNH and any other relevant department.
11. The vehicles shall not be carrying any arms, firearms, or ammunition and other deadly weapons like stick or lathy, cudgel, swords, spears, bludgeons, knives or any other article which is capable of being used for causing physical violence.
12. The applicant/driver will follow the provisions of Motor Vehicles Act & Rules and Representation of People's Act.
13. There should not be any trouble makers viz. drunkard or any irresponsible person in the vehicle.
14. The Permit signed by the undersigned (in original) shall be affixed prominently on the windscreen of the above mentioned vehicle.
15. The violation of any of the conditions by the applicant/Party Candidate/Members during the above period will be liable for prosecution under the relevant law in force.
