- The conditions prescribed in the Model Code of Conduct for the guidance of 4. Political parties and Candidates should be adhered to strictly.
- The Vehicle driver should keep copy of valid Driving License/R.C. Book/PUC/ insurance and produce the same as when demanded by Police Officer/ Special Magistrate or any other authorized officer.
- Not more than 5 persons including drivers be allowed in a vehicle. 6.
- If candidate is absent from constituency, no other person shall be allowed to use the vehicle allotted to him.
- No other vehicle should be allowed to be used by any leader. 8.
- The above vehicle should not be used for Carrying of voters, failing which action 9. u/s 133 (Corrupt practice) and penal action u/s 123(5) of Representation of People Act, 1951 shall be taken.
- The applicant shall ensure that no obstruction to the traffic or flow of traffic 10. takes place on any road and should follow the traffic rules.
- In case of any untoward incident the applicant will be solely responsible for the 11. incident.
- The applicant shall follow any other orders issued by the Administration and 12. Police Department, DNH and any other relevant department.
- The vehicles shall not be carrying any arms, firearms, or ammunition and other 13. deadly weapons like stick or lathy, cudgel, swords, spears, bludgeons, knives or any other article which is capable of being used for causing physical violence.
- The applicant/driver will follow the provisions of Motor Vehicles Act & Rules and 14. Representation of People's Act.
- There should not be any trouble makers viz. drunkard or any irresponsible 15. person in the vehicle.
