PRESS NOTE

An Election to Lok Sabha for PC-U03 Dadra and Nagar Haveli Parliamentary Constituency is to be held on 23rd April, 2019 (Tuesday), on issue of Notification by the President of India, under sub-section (2) of Section 14 of the Representation of the People Act, 1951 (No. 43 of 1951) and published in the Gazette of India on 28th March, 2019 (Thursday), calling upon the Parliamentary Constituency of Union Territory of Dadra and Nagar Haveli to elect member to the House of People, in accordance with the provision of said Act and of the rules and orders made thereunder.

Therefore, in pursuance of Section 30 and 56 of the said Act, the Election Commission of India has notified the following schedule for election to Dadra and Nagar Haveli Parliamentary Constituency.

(1)	4 th April, 2019 (Thursday)	As the last date for nomination
(2)	5 th April, 2019 (Friday)	As the date for the Scrutiny of Nomination
(3)	8 th April, 2019 (Monday)	Last date for Withdrawal
(4)	23 rd April, 2019 (Tuesday) 07.00 AM to 06.00 PM	Date and hours of poll for Dadra and Nagar Haveli Parliamentary Constituency.

As required under Section-31 of the Representation of the People Act, 1951 read with Rule 3 of the conduct of Election Rule 1961 the Returning Officer, Dadra and Nagar Haveli Parliamentary Constituency has issued Notice of Election (Form-1) inviting nominations from the intending candidates.


1. Nomination papers should be delivered to the Returning Officer in his office at the Collectorate, Silvassa between 11.00 AM to 03.00 PM (excluding Public Holiday) w. e. f. 28th March, 2019 (Thursday) to 4th April, 2019 (Thursday) Besides the Returning Officer, Dr. Rakesh Minhas, Resident Deputy Collector(S), DNH, Silvassa, Assistant Returning Officer has also been authorized to receive nomination papers at his office at the Collectorate, Silvassa during the period mentioned above.

2. The nomination forms can be obtained from the office of the Returning Officer.
3. All nomination papers received by Returning Officer and authorized Assistant Returning Officer will be taken up for scrutiny by the Returning Officer himself on 5th April, 2019 (Friday) at 11.00 AM at his office at Collectorate, Silvassa.
4. If a nominated candidate intends to withdraw his nomination, a notice of withdrawal of candidature in Form-5 should be delivered either by a candidate or by his proposer or by his election agent who has been authorized in writing by the candidate to the Returning Officer or to the Assistant Returning Officer specified above at his office not later than 3.00 PM on 8th April, 2019 (Monday).
5. In the event election being contested the date and hours of poll will be as under:-

Date: 23rd April, 2019 (Tuesday)

Hours: Between the hours of 07.00 AM and 06.00 PM.
